- Support the rollout of Solar Hub pilot projects with project partners and communities.
- Monitor developments in South Africa's Just Energy Transition and climate policy.
- Translate complex policy into accessible learning materials and training.
- Coordinate stakeholder engagement, advocacy activities and policy submissions.
- Support monitoring, evaluation, learning and donor reporting.
- Document lessons learned and contribute to communications and case studies.
